  Three board members have 2 absences.
- Letty Valdez has excessive absences, the board unanimously approved retaining her on the board Carson Holton has 4 absences. Unanimously approved to retain him on the board.
- Visitors' Comments David Harbeitner 7:21

The WMNF conference room and lobby were filled with visitors, most showing support for Rob Lorei. A sign-up sheet for speakers was passed so visitors could give their names. More than 50 visitors signed up to speak.

Each speaker was allotted three minutes.

Rob Lorei spoke and thanked his supporters for coming out. He called his firing "the largest crisis that WMNF has ever faced in the history of 41 years. The decision tonight is going to affect the station."

Former board president Michael Bagby spoke about the board's continuity and that WMNF decided to be bigger than a "Podunk" radio station. Urged visitors to read the strategic plan. Believes in the process.

Public affairs programmers who worked with Rob spoke in his favor. Longtime supporters of the station said they lost faith in station management as the result of this termination. Former board members Jeanne Holton and Kathleen Ochshorn spoke in favor of Rob.

"We don't want to be run like a business. We are family." Blannie Whelan

Josh Holton, a news volunteer and former board member of WMNF, said he worked directly in news with Rob Lorei and said he managed the newsroom well. No one is more respectful to listeners calling in than Rob.

Many supporters pointed out that they are longtime financial supporters and the board must be good stewards of the station's finances. "What are ratings for? Ratings are for corporate stations." Peter Delacos

Rob has been a "top performer" in being part of the outreach to the public by WMNF. One supporter said this firing did not even meet the standards and progressive discipline shown in the corporate world. They don't do sudden firings like this. "None of us might have been here if not for Rob."

Alan Lipke urged board to rehire Rob as "talkmaster." From his experience working with the news department, Rob's public face is different than his work as news director. Rob has received written and verbal warnings over 25 years. Does this review look at grievances filed over the past 40 years?

Several supporters pointed out that WMNF is in their will and the potential loss from listeners leaving the station is greater than the board believes.

James Ransom from the Tampa Organization of Black Affairs, was present at the start of the station. You represent everything that the community could want from a radio station. He deserves dignity. He lauded Rob for working to rename Buffalo Avenue to Dr. Martin Luther King Jr. Boulevard and to prevent Tampa General Hospital from going private.

Former board member Lori Karpay said she worries that WMNF is headed to being a run-of-the-mill mainstream station. Rob is not WMNF; we are ALL WMNF.

Veterans for Common Sense pointed out that Rob Lorei won their Thomas Paine Award. We need to keep Rob Lorei.

Rob is the "star player," "father," "heart and soul of this station" "cool" "famous" and "chill guy" and exceptional integrity in journalism." "He devotes his life to this station." What is the objective of getting the best person here?

Several speakers said Rob should be given full autonomy in the news department to avoid this type of thing happening again.

One volunteer programmer lauded Rob for the guidance he gave in teaching him how to do his alternative health program. Sustainable Living host also spoke in support. Another supporter suggested giving fellowships for newspersons to join Rob in the news department.

A bylaw change is needed, some speakers said, to take the hiring and firing authority away from the GM and give it to the board.

Another speaker said if you want a younger demographic, WMNF needs to give us a voice and show us respect, and this situation shows us there is no respect in this.

Visitors' Comments ended. 63 people spoke.

#### **General Manager**

The ratings for January were on the uptick. Overall our market ranking was a .7, matching last January's mark – the highest we've been over a 13 month period. Our daily cume of 22,300 was the highest of the past 13 months. Our time spent listening is back up over 2 hours at 2 hours, 15 minutes. All dayparts were up slightly, except for 3p-7p which was unchanged at a .4. Evening 7p-midnight held strong at 1.0 and weekends were up to a 1.1. Demographically we are still struggling in the 35-44 demo, which inexplicably posted a 0% after showing 8% listening in the Holiday ratings. 92% of our listening is in the 45 to 75+ demographic

### **Programming**

Randy Wind is continuing with another wave of programmer spot checks on formatics. These are primarily during Monday through Friday daytime shows. All in all people are making improvements in identifying themselves, the show and the station and keeping breaks in check. Although Randy discovered one weekend show that did a 7-and-a-half minute break. Yes, they have been informed but clearly we still have work to do on that side of the programming ledger.
